The participants were interviewed using a semi-structured interview format, so depending on how they responded to questions, some questions were skipped for that participant. An example of this occurred when respondents provided answers to some questions before we asked the question. Additionally, some respondents remarked on some questions in a way that allowed for further probing, to gain a more comprehensive explanation on what they mentioned.
